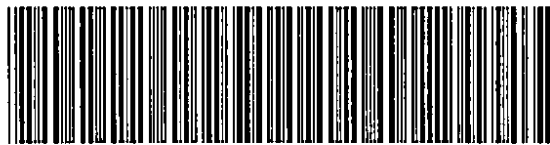

### First:




