ARTICLES OF INCORPORATION 11 JAN 26 PH 3: 48

LAURIER INDEMNITY COMPANY

AN EXISTING WISCONSIN CORPORATION REDOMESTICATING TO IOWA

Pursuant to the provisions of the lowa Code, Laurier Indemnity Company (hereinafter referred to as the "Corporation") a corporation currently domiciled under the laws of the State of Wisconsin, for the purpose of continued in interruption, as a corporation organized under the laws of the State of Iowa, does hereby elect, pursuant to the laws of the State of Iowa, to become redomesticated as an lowa corporation. Upon the taking of effect of these Articles of Incorporation, the Corporation shall be and continue to be possessed of all privileges, franchises, and powers to the same extent as if it had been, at all times during its corporate existence, incorporated under the laws of the State of Iowa; and all privileges, franchises, and powers belonging to said Corporation, and all property, real, personal and mixed, and all debts due on whatever account, all certificates of authority, agent appointments, outstanding insurance policies, capital structure, and all choices in action, shall be and the same are hereby ratified, approved, confirmed and assured to the Corporation, with like effect and to all intents and purposes as if it had been, at all times, during its corporate existence; incorporated under the laws of the State of Iowa. Pursuant to §490.902, 515.2 and 515.78 of the 2009 Code of lowa, for purpose of setting forth its Articles as an lowa corporation, the Corporation hereby adopts the following Articles of Incorporation:

FIRST: The name of the corporation shall be Laurier Indemnity Company.

SECOND: The place in lowa where its principal office shall be located is the City of Cedar Rapids, Linn County, Iowa.

THIRD: The purpose of the corporation shall be to transact, directly or by ceding or assuming reinsurance, any one or more or all of the kinds of insurance described in and authorized by Section 515.48 of the lowa Code as it now exists or may hereafter be amended. The corporation shall have the power and authority to exercise any and all rights, powers, and privileges, and shall be subject to any and all duties and obligations, now or hereafter granted to or imposed upon domestic insurance companies formed for the purpose of transacting such insurance by the laws of the State of lowa, and the corporation shall have the power and authority to engage in any act or activity which is not unlawful for it under the laws of the State of Iowa.



FOURTH: The authorized number of shares of the corporation shall be 3,420,000, all of which shall be common shares, each with a par value of \$1.00 per share.

FIFTH: The paid-in capital of the corporation shall be not less than \$1,000,000 and the contributed surplus of the corporation shall be not less than \$1,500,000.

<u>SIXTH</u>: The Corporation shall have a Board of Directors. The number, term, authority, and other provisions applicable to the Board of Directors shall be applied as set forth in the Bylaws.

SEVENTH: The Directors of the corporation shall have the power to cause the corporation from time to time and at any time to purchase, hold, sell, transfer, or otherwise deal with (A) shares of any class or series issued by it, (B) any security or other obligation of the corporation which may confer upon the holder thereof the right to convert the same into shares of any class or series authorized by the Articles of the corporation, and (C) any security or other obligation which may confer upon the holder thereof the right to purchase shares of any class or series authorized by the Articles of the corporation. The corporation shall have the right to repurchase, if and when any shareholder desires to sell, or on the happening of any event is required to sell, shares of any class or series issued by the corporation. The authority granted in this Article Sixth of these Articles shall not limit the plenary authority of the Directors to purchase, hold, sell, transfer, or otherwise deal with shares of any class or series, securities, or other obligations issued by the corporation or authorized by its Articles.

EIGHTH: A Director or officer of the corporation shall not be disqualified by his office from dealing or contracting with the corporation as vendor, purchaser, employee, agent or otherwise. No contract or transaction shall be void or voidable with respect to the corporation for the reason that it is between the corporation and one or more of its Directors or officers, or between the corporation and any, other person in which one or more of its Directors or officers are directors, trustees, or officers, or have a financial or personal interest, or for the reason that one or more interested Directors or officers participated in or voted at the meeting of the Directors or a committee thereof which authorized such contract or transaction, if in any such case (A) the material facts as to the relationship or interest of such Director, officer or other person and as to the contract or transaction are disclosed or are known to the Directors or the committee, or such members thereof as shall be present at any meeting at which action upon any such contract or transaction shall be taken, and the Directors or committee, in good faith reasonably justified by such facts, authorized the contract or transaction by the affirmative vote of a majority of the disinterested Directors, even though the disinterested Directors constitute less than a quorum; or (B) the material facts as to the relationship or interest of such Director, officer or other person and as to the contract or transaction are disclosed or known to the Shareholders entitled to vote thereon and the contract or transaction is specifically approved at a meeting of the shareholders held for such purpose by the affirmative vote of the holders of shares entitling them to exercise a majority of the voting power of the corporation held by persons not interested in the

contract or transaction; or (C) the contract or transaction is fair as to the corporation as of the time it is authorized or approved by the Directors, a committee thereof, or the shareholders.

<u>NINTH</u>: No shareholder of the corporation shall have, as a matter of right, the preemptive right to purchase or subscribe for shares of any class, new or hereafter authorized, or to purchase or subscribe for securities or other obligations convertible into or exchangeable for such shares or which by warrants or otherwise entitle the holders thereof to subscribe for or purchase any such shares.

<u>TENTH</u>: The registered agent of the corporation is CT Corporation and its address in lowa is: 500 East Court Avenue, Suite 200, Des Moines, Iowa 50309.

<u>ELEVENTH</u>: These Articles of Incorporation supersede the original Articles of Incorporation of Laurier Indemnity Company adopted October 21, 1988, and amendments adopted March 25, 1991, July 29, 1991, December 2, 1994, thereto, which was a corporation organized and existing under the laws of the State of Georgia, and the amendment adopted December 19, 2003 transferring its place of domicile to the State of Wisconsin.

<u>TWELFTH</u>: The Company, as a domestic insurer in the State of Wisconsin has amended and restated its Articles of Incorporation and Bylaws, to transfer its place of domicile to the State of Iowa, thereby becoming a foreign insurer in the State of Wisconsin, and effective as of the date set forth below, is redomesticated to the State of Iowa.
