## ARTICLES OF MERGER OF PROFESSIONAL RECORDS STORAGE & DELIVERY, INC. WITH AND INTO PIERCE LEAHY CORP.

Pursuant to Section 607.1104 of the Florida Business Corporation Act, the undersigned corporations adopt the following Articles of Merger:

FIRST: Pierce Leahy Corp. ("Parent"), is a corporation duly organized under the laws of the State of New York which owns all of the outstanding shares of each class of the capital stock of Professional Records Storage & Delivery, Inc. ("Subsidiary"), a corporation organized under the laws of the State of Florida.

SECOND: The Board of Directors of Pierce Leahy Corp. adopted the following Plan of Merger in accordance with the New York Business Corporation Law:

Merger: On the Effective Date, Subsidiary shall be merged with and into Parent. Parent shall continue its corporate existence and be the surviving corporation.

Articles of Incorporation: The Articles of Incorporation of Parent, as in effect as of the Effective Date, shall remain in effect as the Articles of Incorporation of Parent after the Effective Date.

By-Laws: The By-Laws of Parent, as in effect as of the Effective Date, shall remain the By-Laws of the Parent after Effective Date.

Officers and Directors: The Officers and Directors of Parent as of the Effective Date shall remain the officers and directors of the Parent after the Effective Date.

<u>Conversion of Shares</u>: No shares or any other consideration shall be issued or paid by Parent for the shares of Subsidiary.

THIRD: Parent is the sole shareholder of Subsidiary, there are no other shareholders of Subsidiary entitled to vote, dissent from this action or to whom Parent can mail a copy of the Plan of Merger.

FOURTH: Shareholder approval of the merger was not required.

FIFTH: The Effective Date of the merger shall be the date of filing of these Articles of Merger.
