Pursuant to the provisions of the District of Columbia non-profit Corporation Act, the undersigned adopts the following Articles of Amendment to its Statement of Election to Accept:

FIRST: The name of the Corporation is Catholic Relief Services-United States Catholic Conference, Incpress (Arts)

**SECOND:** The following amendment of the Statement of Election to Accept was adopted by the Corporation in the manner prescribed by the District of Columbia Non-Profit Corporation Act:

The charter of the corporation is hereby amended by striking out the Article First of the Statement of Election to Accept in its entirety and inserting in lieu thereof a new Article First to read as follows:

"FIRST: The name of the corporation (which is hereinafter called the 'Corporation') shall be CATHOLIC RELIEF SERVICES UNITED STATES CONFERENCE OF CATHOLIC BISHOPS"
