The original of this certificate has been cancelled pursuant to the bank's decision to terminate operations of its Miami office and to surrender its license effective April 24, 2001.

For the 30-day period following the closure of the Banco Union, S.A.C.A., Miami agency, there have been no claims filed with this office against your bank. Accordingly, the capital equivalency agreement between Banco Union, S.A.C.A., Bank of America, N.A. and the Department of Banking and Finance is terminated.
