### ARTICLES OF MERGER DOMESTIC BUSINESS CORPORATION

Hospital Baby Picture Service, Inc.

#### Exhibit A

Pursuant to 15 Pa. C.S. § 1901, the following provision of the plan of merger pursuant to which Shiflet Enterprises, Inc. is merged with and into Hospital Baby Picture Service, Inc. amends the articles of incorporation of the surviving corporation as in effect subsequent to the effective date of the plan of merger and is hereby made a part of the Articles of Merger - Domestic Business Corporation. Section 3 of the plan of merger provides that the articles of incorporation of Hospital Baby Picture Service, Inc. shall be the articles of incorporation of the surviving corporation except that, as of the effective date of the merger, paragraph "1" of the articles of incorporation of the surviving corporation shall be deleted and replaced in its entirety with the following: "1. Corporate Name. The name of the Corporation is Shiflet Imaging, Inc."
