Hello M. Cauley,

I just spoke with you about 15 or 20 minutes ago about our Annual Report. I have already filed our Annual Report for subject Corporation, but because we are running into a problem renewing our Florida *Surveying License*, we will need to add two other officers to our Annual Report for MACTEC Engineering and Consulting, Inc., Document No. P33646. Due to the fact that the requirements with the Florida Department of Agriculture & Consumer Affairs, is that the Surveyor of Record has to be listed with the Florida Department of State as an Officer of the Company, they will not renew our Surveying License.

Also, we have run into another big problem, because the Corporation is submitting a Proposal as a subcontractor for a major project with the Orlando International Airport, of which the proposal is due on Tuesday, 3/22/11, and the license to practice surveying has to be submitted with the Proposal, but, since the Florida Department of Agriculture & Consumer Affairs use the Florida Department of State as the source for proof of the Surveyor of Record as being an officer of the Corporation, they will not renew our license because the names below are not listed on your records.
