

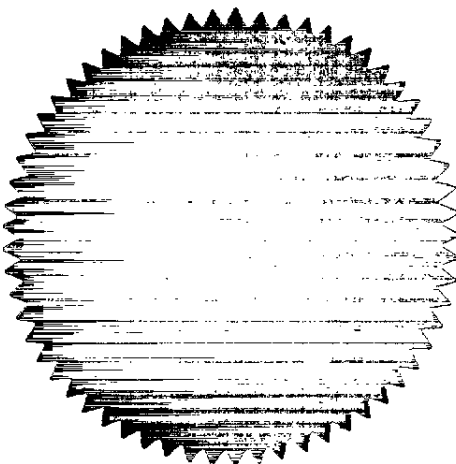
I also certify that by Articles of Amendment filed here November 27, 1996, the name of said corporation was changed to THERMO WEB SYSTEMS, INC.
