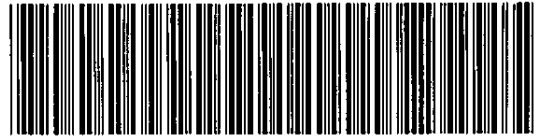



PRELIMINARY STATEMENT:

Protel Services, Inc. is a corporation formed and existing under the laws of the State of Texas. The shareholders and directors of Protel Services, Inc. desire to convert Protel Services, Inc. to a Maryland corporation pursuant to the provisions of the Maryland General Corporation Law, §3-903(d).

THIS IS TO CERTIFY THAT:

FIRST: Protel Services, Inc., a Texas corporation was formed by filing Articles of Incorporation with Office of the Secretary of State, Corporations Divisions, on February 4, 1988 under the laws of the State of Texas (the "Texas Corporation").

SECOND: The Texas Corporation, will be converted to a Maryland corporation known as Protel Services, Inc.

THIRD: The terms and conditions of the transaction described in these Articles were duly advised, authorized and approved by the Texas Corporation in the manner and by the vote required by the laws of the State of Texas, its Articles of Incorporation and Bylaws.

FOURTH: The manner and basis of converting or exchanging issued stock of the Texas Corporation into stock of Protel Services, Inc., a Maryland corporation, and the treatment of any issued stock of the Texas Corporation, not to be converted or exchanged are as follows:

Each issued and outstanding share of Common Stock of the Texas Corporation, on the effective date of the conversion shall and without further act, be converted into, and become one share of Common Stock of Protel Services, Inc., a Maryland corporation.

FIFTH: The conversion shall become effective upon filing these Articles with SDAT (the "Effective Time").

SIXTH: The undersigned acknowledges these Articles (i) have been approved by the directors and the shareholders of the Texas Corporation in the manner required under § 5.03 and §5.17 of the Texas Business Corporation Act and (ii) to be the act and deed of the entity on whose behalf he has signed, and further, as to all matters or facts required to be verified under oath, each of the undersigned acknowledges that to the best of his knowledge, information and belief, these matters and facts relating to the entity on whose behalf he has signed are true in all material respects and that this statement is made under the penalties of perjury.





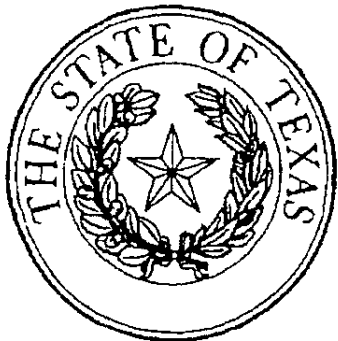
