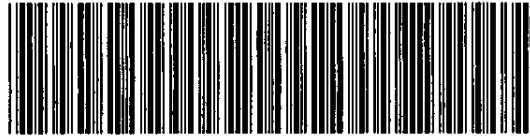

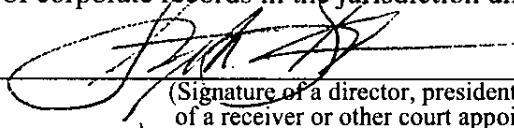

ARTICLES OF INCORPORATION OF
S.C.S. CONTRACTORS, INC.**

THE ARTICLES OF INCORPORATION of S.C.S. Contractors, Inc. filed on May 17, 1990 are hereby amended as follows:

ONE

The current name of the Corporation is S.C.S. CONTRACTORS, INC. (the "Corporation").

TWO

The Corporation hereby adopts the following amendment for the purpose of changing the name of the Corporation to SCS Contractors, Inc., and hereby amends Article 1 by deleting it in its entirety and replacing the same with the following new Article 1:

FOUR

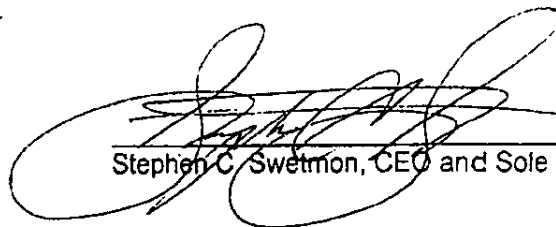
These Articles of Amendment were adopted by the Board of Directors without shareholder action. No shareholder action was required for the adoption of these Articles of Amendment.

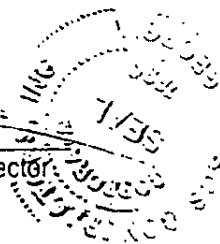
