The undersigned corporations, pursuant to Section 607.1104 of the Florida Business Corporation Act, hereby execute and adopt the following Articles of Merger:

FIRST: BFI Waste Systems of North America, Inc. is a corporation organized under tha laws of the State of Delaware owning one hundred percent of the shares of Attwoods Environmental of Florida, Inc., Jones Road Landfill and Recycling, Inc. and Medx, Inc., all being corporations organized under the laws of the State of Florida.

SECOND: The following plan of merger was adopted by the sole Director of BFI Waste Systems of North America, Inc.:, on September 24.1977.

A. The name of the merged corporations are:
Attwoods Environmental of Florida, Inc., a Florida corporation
Jones Road Landfill and Recycling, Inc., a Florida corporation
Medx, Inc., a Florida corporation

- B. The name of the surviving corporation is:
  BFI Waste Systems of North America, Inc., a Delaware corporation
- C. BFI Waste Systems of North America, Inc. shall be the surviving corporation and does hereby merge with and into itself, Attwoods Environmental of Florida, Inc., Jones Road Landfill and Recycling, Inc. and Medx, Inc. (hereinafter collectively referred to as the "Merged Corporations"). The Articles of Incorporation and By-Laws of BFI Waste Systems of North America, Inc. shall be the Articles of Incorporation and By-Laws of the Surviving Corporation.
- D. On the effective date of the merger, each share of the issued and outstanding stock of each of the Merged Corporations shall forthwith be canceled and no shares of the Surviving Corporation will be issued in exchange therefor. All of the property, rights, privileges, leases and patents of each of the Merged Corporations are to be transferred to and become the property of the Surviving Corporation. The officers and sole director of each of the Merged and Surviving Corporations are authorized to execute all deeds, assignments and documents of every nature which may be needed to effectuate a full and complete transfer of ownership.
- E. The effective date of the merger for tax and accounting purposes shall be September 30, 1997.
