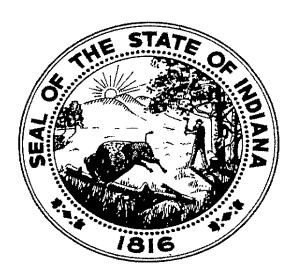

#### ARTICLE ONE
