## ARTICLES OF AMENDMENT TO THE CHARTER OF WIG MARITEL CORPORATION

Pursuant to the provisions of Section 48=20=106 of the Tennessee Business Corporation Act, the undersigned corporation adopts the following articles of amendment to its charter:

The name of the corporation as it currently appears on record is WJG Maritel

The Charter is amended by deleting Article 1 of the Charter and replacing it with the following:

"The name of the corporation is Maritel, Inc.

The Charter is amended to increase the number of authorized shares of the Corporation's Series D 10% Senior Cumulative Redeemable Convertible Pay-in-Kind Preferred Stock by deleting Section 1 of subparagraph (f) of Paragraph 7 of the Charter and replacing it with the following:

There is hereby established a series of Preferred Stock designated "Series D 10% Senior Cumulative Redeemable Convertible Pay-in-Kind Preferred Stock" (herein referred to as the "Series D Preferred Stock" or this "Series") and the number of shares constituting such series initially shall be two hundred fifty thousand (250,000) shares."

- The Charter is amended to change certain of the voting provisions of the Corporation's Series D 10% Senior Cumulative Redeemable Convertible Pay-in-Kind Preferred Stock by deleting Section 6(b) of subparagraph (f) of paragraph 7 of the Charter and replacing it with the following:
  - The affirmative vote of the holders of at least a majority of the outstanding shares of Series D Preferred Stock and Parity Securities, voting together as a group, shall be necessary to authorize a merger or consolidation or a sale of all or substantially all of the assets of the Corporation."
  - The amendments were duly adopted on May 1, 2000 by the directors of the corporation
