THE FLORIDA DEPARTMENT OF STATE  
CORPORATE REINSTATEMENT FEES**

BEFORE ME, the undersigned authority, duly authorized to take acknowledgments and administer oaths, personally appeared HOWARD KENT who, after being by me first duly sworn, deposes and says:

1. That I am the President of WINDSOR PARK EAST, INC., a Florida corporation (hereinafter "Corporation").
2. That on September 24, 1999, the Corporation was administratively dissolved by the Florida Department of State.
3. That the Corporation failed to file its 1999 Annual Report or pay the 1999 Annual Report filing fees within the time prescribed by Florida Statutes Chapter 607 because:
  - (a) the written notice and requirements for filing the Annual Report and pay the Annual Report fee to the Florida Department of State was never received by the Corporation; and,
  - (b) the written notice was never received by the Corporation or its Registered Agent that the Florida Department of State was commencing a procedure to administratively dissolve the Corporation.
4. That the Corporation requests the Florida Department of State reinstate the Corporation upon the payment of its 1999 and 2000 Annual Report fees and the filing of its 2000 Annual Report, which are presented simultaneously with this Affidavit.
5. That the Corporation satisfies the requirements of the Florida Statutes 607.0401.
6. No further ground or grounds exist for the administrative dissolution of the Corporation.

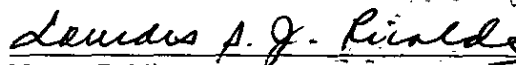
