CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF ELINER REALTY, INC. A FLORIDA CORPORATION

FIRST:

The date of filing of the Articles of Incorporation was November 9, 1992.

SECOND:

The following amendments to the Articles of Incorporation were adopted by the Corporation on November 8, 2002, and shall be added to the original Articles of
