To Whom This May Concern;

I am writing this letter in hopes of having the \$585.00 reinstatement fee waived, for reason as follows;

Back in April of this year my secretary at the time had called in and talked with one of document specialists. We were granted a 30 day extension to the end of May to pay our annual report fee for the corporation of BAKER AND LIPPLY, INC. Towards the end of May we had completed a large remodeling project, the revenue from that job was to help pay accumulated debts and past due bills, the annual report fee was on that list of immediate payables. I remember that i had signed a batch of checks for my secretary to disperse payments, several dozen checks were part of that package. All the checks i had signed were used, so i had naturally assumed that all bills had been paid as planned.

I have received no other correspondence from the state since that time, until i received the notice of administrative dissolution or revocation on Friday 10-24-97. Needless to say i was shocked that it had not been paid and at the price of reinstatement. After doing some digging back thru files and old check registers, i found that indeed it had not been paid, and also had found the original 2nd notice for annual report and the correspondence for the 30 day granted extension (Which i have enclosed).

I am enclosing a check for \$165.00 for 1997 annual report fee and the original 2nd notice document signed. We are a small co. with limited financial resources, the \$585.00 reinstatement fee would be very difficult to come up with by the end of this year. I appologize for the delinquency of this payment, I would greatly appreciate your time and consideration in this matter!
