**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
CANAM ELECTRIC, INC.**

The undersigned, Peter Bourassa, President of Canam Electric, Inc., a Florida corporation (the "Corporation") whose Articles of Incorporation were filed on November 6, 1992, and registered under document number P92000003519, hereby certifies:

1. The name of the Corporation is Canam Electric, Inc.
2. The first sentence of Article I is hereby deleted in its entirety and a new first sentence is inserted in its place as follows:

The name of the corporation is Glebe Electric, Inc.

3. Except as above amended, the Articles of Incorporation of the Corporation, as filed with the Florida Department of State on November 6, 1992, shall remain in full force and effect.

4. The foregoing amendment was unanimously approved by the Sole Shareholder and Sole Director of the Corporation eligible to vote by a unanimous written consent signed by them on May 24, 2004, manifesting their intention that the amendment be adopted, pursuant to Section 607.1003, Florida Statutes. The number of votes cast for said amendment was sufficient for approval.
