1. On December 9, 2020, Thomas Crowley, the individual purported to have reinstated Tool Shack, Inc. on November 13, 2020, filed a Statement of Fact. (See attached Exhibit A) Please provide the name and address of the individual that did in fact file the reinstatement for Tool Shack, Inc., on November 13, 2020. (See attached Exhibit B)

2. Exhibit A also attests that CROWLEY PETROLEUM SERVICES INC 2202 N. WEST SHORE BLVD STE. 200 TAMPA, FL 33607 US, did not authorize the filing of the reinstatement that identified it as the Registered Agent for Tool Shack, Inc. Please provide an explanation for the use of Crowley Petroleum Services as the Registered Agent and, given their denial of such authorization, provide a new Registered Agent.

3. Why should Tool Shack, Inc. not be dissolved for providing materially false information concerning its principals and Registered Agent in its reinstatement filed November 13, 2020? (Exhibit B)

4. Did the filer of the reinstatement on November 13, 2020, knowingly and willfully falsify or conceal a material fact, make any false, fictitious, or fraudulent statement or representation, or make or use any false document, knowing the same to contain any false, fictitious, or fraudulent statement or entry in its filing with the Department of State?

#### STATEMENT OF FACT

::

This Statement of Fact, dated December 9, 2020, is filed with the Florida Department of State, Division of Corporations (the "Division") to correct the corporate records of Tool Shack, Inc., a Florida corporation (the "Corporation"), Document Number P92000003623. We request that this Statement of Fact be added to the corporate records of the Corporation as a matter of public notice.

On November 13, 2020, an identity thief submitted a fraudulent, unauthorized filing with the Division (the "First Fraudulent Filing") that reinstated the active status of the Corporation as a Florida corporation and changed the: (a) principal place of business; (b) mailing address; (c) name and address of the registered agent; and (d) officer/director detail of the Corporation. The First Fraudulent Filing included identifying Thomas Crowley ("Mr. Crowley") as an officer and director of the Corporation and Crowley Petroleum Services, Inc. as the registered agent of the Corporation. The identity thief signed the First Fraudulent Filing as Mr. Crowley. However, neither Mr. Crowley nor Crowley Petroleum Services, Inc. made or authorized this filing with the Division.

Further, on November 19, 2020, the identity thief submitted a fraudulent, unauthorized Amended Annual Report with the Division (the "Second Fraudulent Filing") that changed the: (a) principal place of business; (b) mailing address; (c) name and address of the registered agent; and (d) officer/director detail of the Corporation. The Second Fraudulent Filing included identifying Mr. Crowley as an officer, director and the registered agent of the Corporation. The identity thief signed the Second Fraudulent Filing as Mr. Crowley. However, Mr. Crowley did not make or authorize this filing with the Division.

On information and belief, (1) in 2016, the legal owners of the Corporation sold the assets of the Corporation to GSA Ventures, Inc. (d/b/a Tool Shack) and the Corporation no longer operates as a going concern; and (2) the legal owners of the Corporation cannot be located to provide assistance with submitting a filing with the Division to correct the corporate record of the Corporation.

For the avoidance of doubt, there is no, and has never been any, affiliation between the Corporation and Mr. Crowley or Crowley Petroleum Services, Inc., and neither Mr. Crowley nor Crowley Petroleum Services, Inc. has ever served as a registered agent, director, officer or shareholder of the Corporation.
