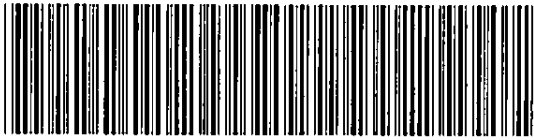

**ARTICLE I. NAME**

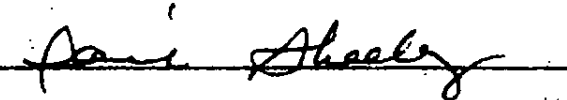

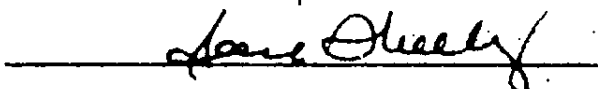

The name of the corporation shall be:

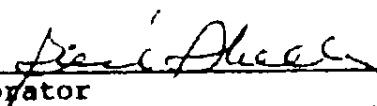
MARINE ECOLOGY SOCIETY INTERNATIONAL, INC.
