It is hereby certified that:

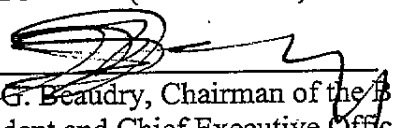
1. The name of the corporation is Videotron (Bay Area) Inc. (the "Corporation").
2. Article I of the Articles of Incorporation of the Corporation is hereby amended to change the name of the Corporation. To effect such change, the first sentence of Article I of the Certificate of Incorporation is hereby amended to read in its entirety as follows:
