I am writing to update the information regarding our request to correct the status of our corporation.

The 1995 annual report was filed in April 1995, with a new address and mailing address filled in on the form you provided. Please see the attached copies and processed check to verify.

Apparently the 1996 report request and forms must have been sent to the old address (which has been knocked down) and never forwarded to us at the new address. For this reason we have not received and therefore not filed our 1996 annual report. Nor have we received or filed our 1997 annual report. We have, however, been paying taxes and licensing fees as a corporation as required and am surprised that no one noticed we had not received and sent in our annual report and therefore were technically dissolved.
