**SECOND:** The Articles of Incorporation were filed on November 12, 1992.

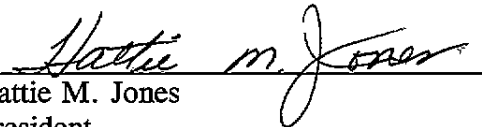
