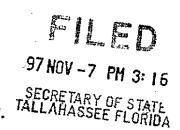

## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF LILLO'S ITALIAN RESTAURANT, INC.



Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation hereby executes the following Articles of Amendment for the purpose of amending its Articles of Incorporation:

- 1. The name of the Corporation is "LILLO'S ITALIAN RESTAURANT, INC."
- 2. The Articles of Incorporation of this Corporation are hereby amended to change the name of the Corporation to Strategic Outsourcing Inc. of FL, so that, as amended, Article I of the Articles of Incorporation shall read as follows:

## "ARTICLE I - NAME

The name of the corporation shall be: Strategic Outsourcing Inc. of FL."

- 3. The amendment was adopted on November 4, 1997.
- 4. The amendment was approved by all of the shareholders of the Corporation who are entitled to vote and the number of votes cast for the amendment was sufficient for approval.
