14. The court holds that the defendant's proposed gift, the trust, is judicially perfected and thus, is equally as binding as a deed in favor of the defendant's family. The defendant's gift is not complete until the actual receipt of the beneficial interest by the trust, and is complete and binding upon the defendant only if the gift is complete at the time the deed is executed. The court holds that the completion of the transfer of the trust is postponed for some time, the receipt of the property by the defendant's family, and that the gift is not complete at the time the deed is executed. The court holds that the trust is not judicially perfected.
