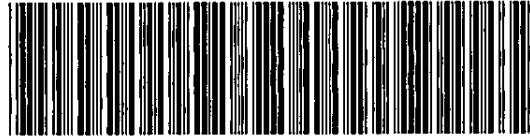




FIRST: The name of the corporation is UTILITY AUDIT SERVICE, INC. (the "company").
