Enclosed please find a check for reinstatement of our profit corporation. In reviewing our file on the internet, it appears that we owe for the years of 1999 and 2000. Enclosed please find a check for 2 years at \$61.25 plus the supplemental fee of \$88.75 per year for a total of \$300.00.

We would like to request an abatement of the \$600 reinstatement fee. The emergency county control (911) necessitated that a physical address be on every property in the county and it took several years to accomplish and number each and every business and residence. The post office would not deliver mail without the physical address being noted on all mailing. Our review on the internet noted a principal address of Rt 1 Box 45, Wauchula, Fl 33873. We never received the annual registration for the last two years and feel the post office was in error. Please abate the \$600 reinstatement fee.
