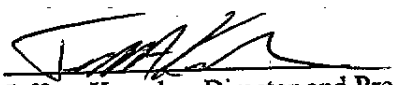
ARTICLES OF AMENDMENT

PARADISE TREE SERVICE, INC.

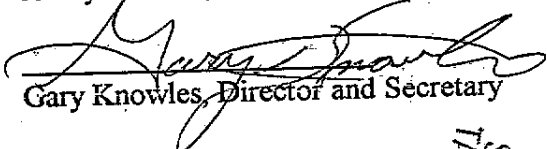
