Please find enclosed our check in the amount of \$315.00 for the 1997 and 1998 corporate filing fee. Per my conversation with Andy Dunlop of your office, I would like to take this opportunity to kindly request that you reconsider the \$750.00 Reinstatement Fee that has been opposed on our small company (husband and wife only).


Firstly, in April of 1997, we moved our offices from Miami Lakes to Plantation, Florida and notified your offices of the new address. Inadvertently, your office never received this information and continued to forward the mail to our old address. As you know, the post office only forwards mail to the new address for a limited time only and then returns any and all undeliverable mail to the sender.

Secondly, in or about the same time, our Registered Agent and Certified Public Accountant, John Mese from Mese & Associates, PA of Miami Lakes was arrested for alleged murder and the FBI closed his offices from one day to another. Our company records were not retrievable and corporate documents were not passed onto us. Today, Mr. Mese is incarcerated and his offices are not operating.

Since this incident, we hired Kwal & Oliva Associates, PA of Miami to handle our books, but were unhappy with their work and discontinued their services. Currently, my husband William H. McFeely, Vice President of Watson-McFeely & Associates is handling the accounting responsibilities for the business.

As you can see from our previous records, we have always been prompt in the past to file annual reports, but due to the unique circumstances mentioned above, we were unable to do so. We thank you in advance for your understanding and cooperation and look forward to a positive response from your Review Board.
