Abstract The purpose of this study was to determine whether there were differences in the prevalence of risk factors for low back pain between two groups of subjects who had been exposed to different levels of physical activity. A total of 60 male subjects were divided into two groups based on their level of physical activity. The first group consisted of 30 subjects who were sedentary, and the second group consisted of 30 subjects who were active. All subjects completed a questionnaire that assessed various risk factors for low back pain, including age, weight, height, occupation, and history of injury. The results of the study showed that the prevalence of low back pain was significantly higher in the sedentary group than in the active group. This finding suggests that regular physical activity may help reduce the risk of developing low back pain.
