To Whom It May Concern:

Attached is an Application for Corporation Reinstatement and a check in the amount of \$300 for the above referenced taxpayer, David Davis Electric, Inc.

This corporation was incorporated December 14, 1992. Its sole officer and director has a mailing address of 6 Atlantic Avenue, Key Largo, FL 33037.

However, the name of the Registered Agent for Service of Process, Barbara A. Winkler, was incorrectly spelled (Wiknkler), is not at the address registered with the Secretary of State and is no longer involved with this corporation.

Unfortunately, this corporation's sole shareholder, officer and director, David A. Davis, has been extremely ill and suffers with long term medical conditions caused by cancer. He has undergone a number of medical therapies that have rendered him disabled.

Because of his illness, a number of corporate reports and filings were misplaced, discarded, missed and/or not completed. Additionally, the Registered Agent for Service of Process either did not receive or forward your Notices of Dissolution to the corporation, and in particular, David A. Davis. Because of this and as a consequence of David A. Davis was undergoing extensive medical treatments, the corporation never received the Florida Secretary of State Annual Report renewal notice, nor did it receive the Florida Secretary of State notices of dissolution.

Consequently, this corporation never filed its 2002 Florida Annual Report.

The sole officer and director is in the process of winding up his affairs and we have been engaged to oversee the completion outstanding business obligations. Upon internet review of the filing status of this corporation, we discovered that the 2002 Florida Annual Report had never been filed, again, due to the medical condition of David A. Davis. Prior to his medical problems, David A. Davis, was very diligent submitting the corporation's Florida Annual Report.

**Pursuant to discussions with your offices (850) 245-6059, please abate the \$600.00 reinstatement fee. We were instructed to send \$300 with this request for Reinstatement.**

Please abate the Reinstatement Fee and bring this corporation current.
