**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
BIOFILTRATION SYSTEMS, INC.**

The Articles of Incorporation of the above-named corporation (the "Corporation"), filed with the Department of State on the 17th day of December 1992, and assigned Document Number P92000012596, are hereby amended pursuant to a written consent in lieu of meeting executed and approved by the holders of all of the Corporation's common stock and all of the Corporation's Directors on the 28th day of February 2000, as follows:

ITEM 1


1. ARTICLE IV is hereby amended to read as follows:


ARTICLE IV
