

# AMENDED AND RESTATED ARTICLES OF INCORPORATION OF LENNAR MORTGAGE HOLDINGS CORPORATION

The undersigned, Zena M. Dickstein, being a duly elected Vice President of LENNAR MORTGAGE HOLDINGS CORPORATION, a Florida corporation (the "Corporation"), hereby states as follows on behalf of the Corporation:
