We the undersigned President and Secretary of SERVICE INDUSTRIES, INC., a Florida Corporation organized under the Law of the State of Florida, do hereby, for purposes of complying with Sections 607.1006 and 607.10025, Florida Statutes, make and attest these Articles of Amendment of the Articles of Incorporation, and certify as follows:

1. The name of the Corporation is SERVICE INDUSTRIES, INC.
2. Article 3, Section 3.1 of the Articles of Incorporation of Services Industries, Inc., is amended to read as follows:

ARTICLE 3.

Capital Stock
