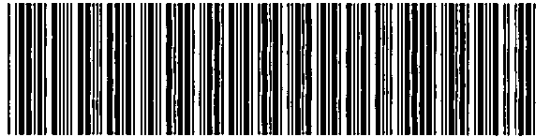



Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, filed December 28, 1992, and assigned document number P92000014107, as amended on January 3, 1995 and July 1, 2002:

1. The name of the corporation is Devore & Devore, P.A.
2. Article I of the Articles of Incorporation is amended to change the corporate name from Devore & Devore, P.A., as amended on July 1, 2002, to Devore, Devore, Karden & Hernandez, P.A.
3. This amendment shall be effective January 1, 2009.
