

ARTICLES OF AMENDMENT

The following provisions of the Articles of Incorporation of EVANS APPRAISAL, INC., a Florida corporation, filed in Tallahassee, Florida, on January 28, 1992, effective January 1, 1993, are hereby amended in the following particulars:

1. Article I shall be amended as follows:

2. Article IV shall be amended as follows:


ARTICLE IV - PURPOSE
