ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION  
OF  
J.A.B. INTERNATIONAL TRADING CO.

WHEREAS, the name of the corporation is J.A.B. INTERNATIONAL TRADING CO. (the "Corporation");

WHEREAS, the Corporation was incorporated pursuant to provisions of the Florida Business Corporation Act on December 1992; and

WHEREAS, the Corporation, by and through its Board of Directors and pursuant to the provisions of Sections 607.1005 and 607.1006 of the Florida Business Corporation Act, hereby desires to amend the aforesaid Articles of Incorporation.

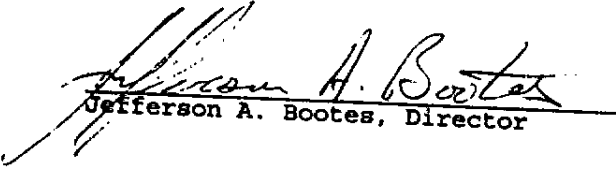
NOW, THEREFORE, the undersigned, as a member of the Board of Directors of the Corporation, hereby amends the Articles of Incorporation as follows:

1. Amend Article 4 - Article 4 shall be amended in its entirety to read as follows:
  - (4) The total number of shares of capital stock which the corporation has the authority to issue is one hundred thousand (100,000) shares of common stock at \$0.01 par value per share.

Except as modified herein, the Articles of Incorporation of J.A.B. INTERNATIONAL TRADING CO. shall be and remain in full force and effect.

The foregoing amendment to the Articles of Incorporation was adopted and approved by a Board of Directors' Action By Written Consent dated July 15, 1996. No shareholder action was required in connection with this amendment.
