ACTION BY WRITTEN CONSENT OF SOLE SHAREHOLDER AND SOLE DIRECTOR IN LIEU OF SPECIAL MEETING OF

The undersigned, being the sole shareholder and sole director of the above named corporation, a Florida corporation, does hereby consent in writing to the adoption of the following resolutions, taking the action in lieu of a meeting, as permitted by Section 607.0704 and Section 607.0821 of the Florida Statutes.

RESOLVED AS FOLLOWS.

- 1. That the sole director and sole shareholder determined it is in the best interests of the corporation and its shareholder to completely liquidate and dissolve the corporation.
- 2. That the appropriate officers of the corporation have distributed in liquidation to the shareholder in cash or in kind, all of the assets of the corporation, by executing and delivering to the shareholder all necessary deeds and documents of conveyance and by transferring and assigning to the shareholder all of the assets of the corporation.
 - 3. That the corporation has paid all of its ascertained liabilities.
- 4.
