1. The name of the corporation is SHAPIRO, BLASI & WASSERMAN, P.A. (the "Corporation").
2. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

Article I – Corporate Name

The name of this corporation shall be SHAPIRO, BLASI, WASSERMAN & GORA, P.A.

3. This Amendment was recommended by the board of directors to the Corporation's shareholders on August 19, 2005.
