

C. All debts, obligations and liabilities of the corporation have been paid or discharged.


D. All the remaining property and assets of the corporation have been distributed among its shareholders in accordance with their respective rights and interests.

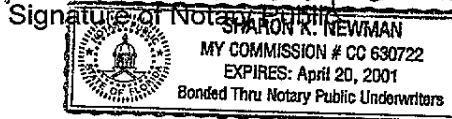

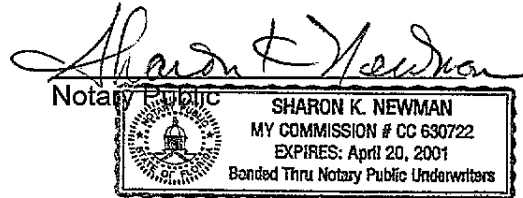
