ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF
CURRY'S AUTOMOTIVE OF LEE COUNTY, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is **CURRY'S AUTOMOTIVE OF LEE COUNTY, INC.**
2. The following amendments of the articles of incorporation were adopted by the shareholders and directors of the corporation on January 31, 1997, in the manner prescribed by the Florida Business Corporation Act: The corporate name shall be changed to **Curry's TOWING & RECOVERY, INC.** Further, substantially all of the assets of **CURRY'S AUTOMOTIVE OF LEE COUNTY, INC.** have been sold to Timothy Zumwalt, who also bought the immediately aforescribed corporate name.
3. The number of shares of the corporation outstanding at the time of adoption was **100**; and the number of shares entitled to vote on the amendments was **100**. JUDY CURRY owns **50** shares and her husband ROBERT CURRY owns **50** shares.
4. The designation and number of outstanding shares of each class entitled to vote on the amendments as a class were as follows: All shares are of one (1) class common stock.
5. All of the outstanding shares of the corporation voted for the aforescribed name change.

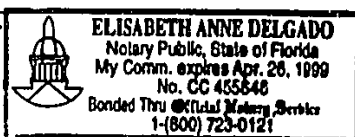




