Dear Leslie Sellers:

This letter is in response to our phone conversation on March 2, 1998. On February 13, 1998 I submitted all the documents and the appropriate fees to reinstate my Corporation. The mailroom separated everything when it arrived and at the present time it is all still pending.

On May 12, 1997 I received a letter from the Division of Corporations informing me that my Corporation had been dissolved. This was due to my failure to file my 1996 Corporate Annual Report. Since I have moved twice and changed my name I never received a notice in 1996 that it was not done. I wrote a check for \$200.00 on April 10, 1996 and have a copy of the form I used in 1996 to file the Annual Report. Copies of this were sent in February. My bank did a search and the check for 1996 was never cashed.

When I called your office in January, I was told you would waive the penalty fees and all I had to do was fill out all the proper documents for a name change and reinstatement. This was done in February and it was returned to me all separated with two checks missing. I sent four checks totaling \$558.75.

Checks were written as follows:

- \$35.00 (Fee for Articles of Amendment) Has been cashed.
- \$200.00 (1996 Annual Report) Was not returned.
- \$165.00 (1997 Annual Report) Was returned to me.
- \$158.75 (1998 Annual Report and Status) Was returned to me.

Since the check for \$200.00 is not enough for reinstatement and was returned to the wrong address, I have included another check for \$200.00. Thank-you for your help in this matter. I had no idea it could become so complicated.
