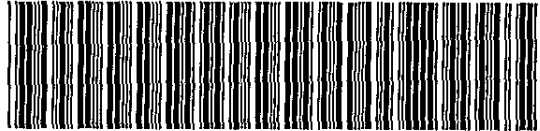

BAXTER, STROHAUER & MANNION, P.A.

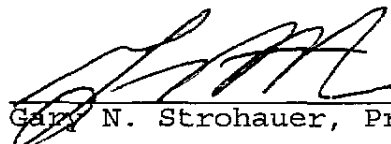
1. Article I of the Articles of Incorporation of BAXTER, STROHAUER & MANNION, P.A. is deleted in its entirety and the following is added in its place:

2. The foregoing Amendment was adopted by the shareholders of this corporation on the 31st day of October, 2002.

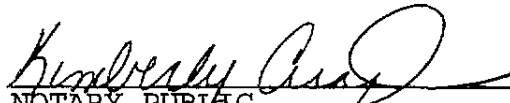

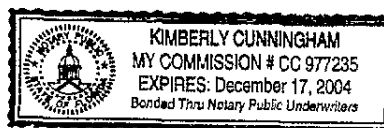
