1. Richard F. Parker is the Director of SONOMED OF SOUTH FLORIDA, INC. a Florida corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on August 25, 1994.

6. No further ground or grounds exist for the administrative dissolution of the Corporation.
