Dear Division of Corporations Staff:

On October 28, 1997 I received notice that effective September 27, 1997 my corporation had been administratively dissolved or revoked. This action occurred due to my failure to pay my annual corporation fee. I now recognize that remembering to pay the fee is completely my responsibility. However, until this week I did not remember that an annual fee was required. This year, my lack of attention to this matter was complicated by the fact that after moving the location of my office my business address was not changed (I thought I changed it by changing the address of the registered agent). If the mail carrier had forwarded the notices your office was sending I would have realized this sooner. However, for some reason the only notice forwarded was the notice of administrative dissolution or revocation dated September 27, 1997.

Based on the above factors, one of your staff members (contacted by phone on 10/29/97) suggested that I write the Division and ask that my file be reviewed. She explained that it might be possible for me to get a one-time exception to the penalty fees and reinstate my business for the cost of the initial filing fee of \$175. A check is enclosed for this amount.

As noted above, I realized the responsibility of making sure the filing fee is paid on time is completely mine. Also, I recognize that payment of the filing fee is necessary for me to stay in business. Further, I realize that your department has a burdensome task in processing annual filing fees for the huge number of corporations registered in this state. Therefore, I assure you that regardless of the outcome, your department will not be concerned with my filing fee being delinquent in the future. Your consideration of this matter will be greatly appreciated.
