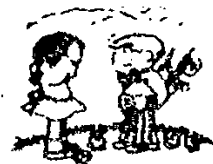

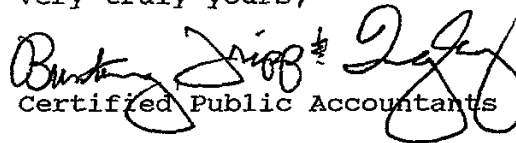
During the first half of 1998, Mr. Blick was divorced from his wife, Christine Y. Blick. Mrs. Blick had formerly maintained all of the records and filed all of the tax and information reports for the corporation. 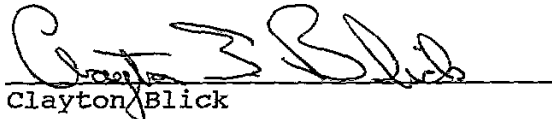
