

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF <u>WPALM, INC.</u>



### **Document #P93000001765**

Pursuant to the provisions of Section 607.1006, Florida Statutes, this *Florida Profit Corporation* adopts the following amendment to its Articles of Incorporation.

- 1. The name of the corporation is WPALM, Inc. (hereinafter referred to as the "corporation").
- 2. The Articles of Incorporation of the corporation are hereby amended by striking out Article III in its entirety and inserting in lieu thereof the following:

# ARTICLE III PURPOSE

This corporation is organized for the following purposes:

- (a) To purchase and sell real and personal property related to the burial of the dead, and all other things necessary and incidental to such purpose and purposes, or designed to promote such purpose or purposes;
- (b) To do all things and to exercise all powers now or hereafter conferred upon corporations of all the general character of this corporation by the laws of the State of Florida.
- 3. This amendment was approved by the shareholders of the corporation on July 16, 2004. The number of votes cast for the amendment by the shareholders was sufficient for approval.
- 4. This amendment shall be effective upon the filing with the office of the Secretary of State of the State of Florida.
