OF COMMUNITY REAL ESTATE SERVICES, INC.,**



Second: This Amendment was adopted by the unanimous vote of the shareholders of the Corporation on the 28 day of September, 2007.



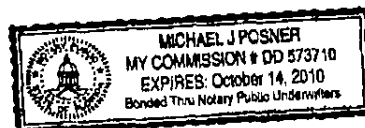
