**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
INTERNATIONAL CINEMA SERVICES, INC.**

1. The name of the corporation is INTERNATIONAL CINEMA SERVICES, INC. (the "Corporation").
2. The date of filing of the Articles of Incorporation of the Corporation with the Secretary of State of the State of Florida was January 14, 1993, under Document Number P93000003426.
3. These Articles of Amendment to Articles of Incorporation have been duly authorized and directed by Written Consent of the Sole Director and the Sole Shareholder of the Corporation dated May 1, 2007 and the number of votes cast for the amendment was sufficient for approval.
4. The Articles of Incorporation of the Corporation are hereby amended by the restatement of Article I as follows:

"ARTICLE I - NAME

The name of the corporation shall be:

CONTINENTAL FILM & DIGITAL LABS, INC.

The address of the principal office of this corporation shall be 1998 NE 150th Street, North Miami, Florida 33181 and the mailing address of the corporation shall be the same."

5. All other provisions of the Articles of Incorporation of the Corporation shall remain in full force and effect without any modification thereof.
