Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendments to its Articles of Incorporation:

FIRST: Article 2 of the Articles of Incorporation provides:

- B. Provide services of shipping of any kind of merchandise and goods locally and internationally.
- C. Import any kind of merchandise, equipment, supplies, services and goods from any country.
- D. Purchase and sale of goods and merchandise of every nature, type, sort and description; and shipping of the same by any and all means of transportation within the State of Florida from elsewhere, including internationally.
- E. To transact any and all lawful business transactions permitted under the Law of the state of Florida

THIRD: The date of the adoption of this amendment is the 1 September 1998.

FOURTH: The amendment was adopted by the Board of Directors. No Shareholder action was required for adoption.

FIFTH: This amendment shall be effective upon the filing with the Secretary of State of Florida.
