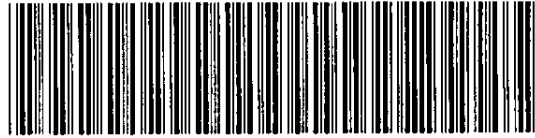

**FIRST:** The name of the Corporation is Wagner Development, Inc. ("Corporation").


**SECOND:** The Corporation's Articles of Incorporation were filed on January 19, 1993 assigned Document Number P93000004471.
